PLEASE NOTE:

1. **Public consumption of alcoholic beverages or drugs on fairgrounds property is not permitted.**
2. The spaces for R.V.'s are 12' X 30'. We are required to keep 10 feet between units. You must keep everything within your space (including tents and ropes). Oversized camping units will be assigned to outside the south fence (South Out).
3. If you are planning to put more than one (1) form of accommodation within your space you must have prior approval.
4. There will be quiet time in the RV Park from 11:00pm until 6:00am.
5. There **Shall** be adult supervision at each leased site during the entire Fair. Adults are expected to provide good examples for youth, both in speech and in actions.
6. **ABSOLUTELY NO ANIMALS OF ANY KIND allowed at any time in any camping areas.**
7. **NO Dogs allowed on the fairgrounds. NO Bicycles, Scooters, Skateboards, Roller Blades/Skates, Lasers, Toy Guns or any other item that may be considered dangerous or a nuisance – these are NOT allowed on the fairgrounds.**
7. **FIRE LANES MUST BE KEPT OPEN AT ALL TIMES.**
8. **AIR CONDITIONERS MAY NOT BE USED AT ANY TIME** – circuits will overload and inconvenience all.
9. Camping space assignments will be determined by the Fair Camping Committee and may be changed/canceled at any given time. The Okanogan County Fair is not responsible for theft, fire or damage to any camping units brought onto the fairgrounds. In addition, by Sept. 16, (the first Friday following the fair) any camping unit left beyond that date will be charged a \$25/per night RV fee. If such vehicle is left unattended and fees are not paid in advance, after one additional week (Sept. 23), any unit remaining will be towed at the owner's expense by Randy's Towing of Okanogan. The demand for camping space during Fair time has grown to an almost unmanageable level. We will try our best to fill your request. We want everyone to have a good experience at the Fair. Please help us by returning your application ASAP. Late applications will be placed according to available space.

****Special Note****

Due to longer RVs and more tip-outs, please be honest with your measurements. We will try to accommodate some larger RVs, but space is limited and we cannot do so without truthful information. Thank you!
