### ENVIRONMENTAL CHECKLIST

#### *Purpose of checklist:*

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. An environmental impact statement (EIS) must be prepared for all proposals with probable significant adverse impacts on the quality of the environment. The purpose of this checklist is to provide information to help you and the agency identify impacts from your proposal (and to reduce or avoid impacts from the proposal, if it can be done) and to help the agency decide whether an EIS is required.

#### *Instructions for applicants:*

This environmental checklist asks you to describe some basic information about your proposal. Governmental agencies use this checklist to determine whether the environmental impacts of your proposal are significant, requiring preparation of an EIS. Answer the questions briefly, with the most precise information known, or give the best description you can.

You must answer each question accurately and carefully, to the best of your knowledge. In most cases, you should be able to answer the questions from your own observations or project plans without the need to hire experts. If you really do not know the answer, or if a question does not apply to your proposal, write "do not know" or "does not apply." Notice of proposal and threshold determination will be published on September 27, 2017. A 14 day comment period will begin with publication of notice. Following review of comments and final SEPA determination a public hearing will be scheduled with

the Okanogan County Regional Planning Commission. Following the planning commission hearings and recommendation a public hearing will be scheduled in front of the Board of County Commissioners to consider adoption.

7. Do you have any plans for future additions, expansion, or further activity related to or connected with this proposal? If yes, explain.

The purpose of the proposal is to amend OCC 17A.270 Nightly Rentals to eliminate the amortization period and the annual permit renewal. The requirement for the annual permit will be placed in OCC 5.06 (new section as a requirement for business license. All nightly rentals will be required to comply with OCC 17A.270 as amended except those nightly rentals operating legally before September 6, 2005. Records indicate there are approximately 16 legal pre-existing nightly rentals operating in the Methow Review District.

8. List any environmental information you know about that has been prepared, or will be prepared, directly related to this proposal. An environmental impact statement was prepared when the revised zone code OCC 17A was reviewed and adopted in July of 2017.

If adopted the revised OCC 17A.270 would apply county-wide on a project specific basis. There are no applications pending that will be affected by this proposal.

This proposal will not become effective until implemented by the Board of County Commissioners.

The purpose of the proposal is to amend OCC 17A.270 Nightly Rentals to eliminate the amortization period and the annual permit renewal. The requirement for the annual permit will be a new section in OCC 5.06. Nightly rentals previously operating outside of planned developments as legal pre-existing land uses will continue in accordance with OCC 17A.330. It is estimated there are 16 nightly rentals (overnight transient accommodations) currently operating in the Methow Review District as legal pre-existing land uses.
